## Committee's Report For the year ended 30 June 2025

#### **Principal Activities**

The Association is a charity whose purpose is the protection and enhancement of the natural environment and the promotion of sustainability and biodiversity.

#### **Mission**

Through inclusive and diverse collaboration, give a voice to members, enable effective management of covenanted properties and grow the profile of private land conservation.

#### **Significant Changes**

No significant changes in the nature of the entity's activity occurred during the financial year.

#### **Operating Result**

A total of \$40,739 was received in donations from members or donations in-kind (Ecolands Collective Ltd), grants & interest to fund our operations which totalled \$30,088. This left a net bank balance of \$16,134.

#### **Financial Performance**

The Association is solvent. The expenses and services of the organisation have been met by the generous contributions from the Rendere Trust and Ecolands Collective Ltd and a number of members.

#### **Going Concern**

This financial report has been prepared on a going concern basis which contemplates continuity of normal charity activities and the realisation of assets and settlement of liabilities in the ordinary course of activities. The ability of the Association to continue to ope as a going concern is dependent upon the ability of the Association to generate sufficient cashflows from operations to meet its liabilities. The Board members of the Association believe that the going concern assumption is appropriate.

#### Ongoing funding of its operations

There has been no change in the environment in which the Association has been operating although in the coming 2026 financial year, Ecoland Collective's support going forward will be limited to providing advice and IT support. The Association's aim in meeting its needs is to seek ongoing funding via grants and from like-minded companies and philanthropists.

#### **Uncertainties**

The principal uncertainty the organisation faces is the continuing generosity of its donors, but there is also the legal and regulatory environment.

#### Notes to the Financial Statements for the year ended 30 June 2025

#### 1. Statement of Significant Accounting Policies

This financial report includes the financial statements and notes of the Land Covenantors Victoria Inc, an incorporated association, which is incorporated in Victoria under the Australian Charities and Not For Profit Commission Act 2012 and the Associations Incorporation Reform Act 2012.

#### **Basis of preparation**

This financial report is a special purpose financial report prepared to satisfy the financial reporting requirements of the Australian Charities and Not For Profit Commission Act 2012 and the Associations Incorporation Reform Act 2012. The Committee has determined that the Association is not a reporting entity and also a not-for-profit entity.

The financial report has been prepared on an accrual basis and is based on historical costs, modified, where applicable, by measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The following is a summary of the material accounting policies adopted by the Association in the preparation of the special purpose financial report.

#### **Accounting Policies**

#### a. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks and other short-term highly liquid investments with original maturities of three months or less. There are no overdraft facilities.

#### b. Revenue

Revenue is measured at the fair value of the consideration received.

Revenue is brought to account when received and to the extent that it relates to the period it is received in.

#### **Donations in Kind**

The Association is grateful for the support \$25,833 given to it by the Ecolands Collective Ltd in funding its administration and IT costs, as well as the funding \$14,404 by other member donors.

#### Grants

As a member of Landcare Victoria, the Association is entitled to an annual Grant from a local Catchment Authority.

#### **Interest Income**

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

#### c. Operational Expenditure

Most operational expenditure was generously provided by Ecolands Collective Ltd.

#### d. Legal Advice Expenditure

In 2024 advice was needed on the setting up of the our DGR application with the Australian Charities and Not-For Profits Commission.

#### e. Income Tax

By virtue of its aims as set out in the constitution, the Association qualifies as an organisation exempt from income tax.

#### f. Good and Services Tax (GST)

As the entity is not currently registered for GST, revenues, expenses and assets are recognised inclusive of GST.

#### g. Related Party Transactions

The Committee Members act in an honorary capacity and are not paid for their services as Committee Members.

There were no transactions with related parties during the 2025 financial year.
